GENERAL RULES

Prizes will be given for Best Team Costume, Peanut (youngest*) Rider and Jack Benny (oldest horse & rider combined ages**). Teams must consist of 2 or 3 riders. Western Teams must include at least one western rider. Junior teams must include at least one rider less than 18 years of age. A waiver must be signed by a parent/guardian for all junior riders. **Entries must be received with payment by Friday, Oct. 23rd. NEW: No same day registrations this year!!** Early registration is encouraged to reserve preferred start time. Unless you have received confirmation of a start time, do not assume you have one. Times confirmed by email or phone. **Ride times are available between 8:30 am and 11:30 am. Riders must finish by 1:30 pm to be included in Pace Results.**

 - Horses must be in condition. NBLA officials have the authority to disqualify any animal that is in distress
 - Passing of other teams on the course must be done at a WALK or risk disqualification.
 - Proper trail etiquette is required at all times
 - Please keep all dogs on leashes and clean up after them.
 - There will be no refunds unless the pace is cancelled or doctor/vet certificate is received before Pace Day.
 - ****NEW** Please bring your own refreshments. Due to COVID, no food or drink will be provided.**
 - ****NEW** No bathroom facilities at the site. Please make your own arrangements.**
 - Please bring water for your horse– none is available at the pace.
 - Please clean up around your trailer before leaving

I/We the undersigned, (the “Rider/s or Participant/s”) is permitted to participate in or volunteer at **The Frost on the Pumpkin Hunter Pace** sponsored or organized by the Newtown Bridle Lands Association, Inc.(“NBLA”) on October 24 or 25, 2020 in Newtown, CT. The Rider and his/her parents or guardian (if Rider is less than 18 years of age) agree that NBLA, its officers, directors, agents, members, volunteers and assistants, as well as the landowners whose lands are used, crossed, abutted in this **The Frost on the Pumpkin Hunter Pace** (collectively the “Releases”) shall not be liable for, and agree to release them from any accident, personal injury, death or property damage that may be sustained by any person or entity, including without limitation the Rider, as a result in whole or in part from the Rider’s participation in **The Frost on the Pumpkin Hunter Pace**. This agreement is binding on the Rider and his/her parents or guardian whether or not said accident, personal injury, death or property damage is due in whole or in part to the negligence of the Releasees. The Rider and his/her parents or guardian agree to defend and indemnify the Releasees from any claims, demands or suits arising from the Riders participation in The Frost on the Pumpkin Hunter Pace, including without limitation those arising in whole or in part from the negligence of the Releasees.

I understand that horseback riding involves risks from natural and man-made conditions, including for example, failure of riders to control their horses, the existence of tree branches and roots, animal burrows, erosion, slippery and uneven footing, rocks and other conditions. I agree that natural and man-made conditions are an inherent risk of horseback riding. I voluntarily assume the risks of encountering these conditions, including without limitation conditions caused in whole or in part by the negligence of the Releasees.
