**IMPORTANT CHANGES:** Because of COVID 19, there will be no food supplied by the organizers. Water will be provided at the finish line. A port-a-potty will be provided.

### GENERAL RULES

Ribbons will be given for Best Team Costume, Peanut (youngest\*) Rider, Jack Benny (oldest horse & rider combined ages\*\*), and the highest scoring Junior NBLA member (under 18). Teams must consist of 2 or 3 riders. Western Teams must include at least one western rider. Junior teams must include at least one rider less than 18 years of age. A waiver must be signed by a parent/guardian for all junior riders. **Entries must be received with payment by Wednesday, Oct. 20. No same day registrations this year!!** Early registration is encouraged to reserve preferred start time. Unless you have received confirmation of a start time, do not assume you have one. Times confirmed by email or phone.

**Ride times are available between 8:30 am and 11:30 am. Riders must finish by 1:30 pm to be included in Pace Results.**

**RULES AND REGULATIONS:**

- As with all of our events, we are guests on the property so please be respectful of the landscape, pedestrians and automobiles.
- **Pace entries must be received by Wednesday, October 20<sup>th</sup>.**
- Helmets are required for all riders – No exceptions.
- Horses must be in condition. NBLA officials have the authority to disqualify any animal that is in distress
- Passing of other teams on the course must be done at a WALK or risk disqualification.
- Proper trail etiquette is required at all times
- Please keep all dogs on leashes and clean up after them.
- There will be no refunds unless the pace is cancelled, or doctor/vet certificate is received before Pace Day.
- **Please bring your own refreshments. Due to COVID, only water will be available at the finish line.**
- Please bring water for your horse—none is available at the pace.
- Please clean up around your trailer before leaving
- **Every rider or parent/guardian must sign and turn in the Release of Liability below in order to receive a Start Packet.**

**READ AND UNDERSTAND THIS BEFORE YOU SIGN!**

I/We the undersigned, (the “Rider/s or Participant/s”) is permitted to participate in or volunteer at **The Frost on the Pumpkin Hunter Pace** sponsored or organized by the Newtown Bridle Lands Association, Inc.(“NBLA”) on October 23 or 24, 2021 in Newtown, CT. The Rider and his/her parents or guardian agree to defend and indemnify the Releasees from any claims, demands or suits arising from the Riders participation in The Frost on the Pumpkin Hunter Pace, including without limitation those arising in whole or in part from the negligence of the Releasees.

I understand that horseback riding involves risks from natural and man-made conditions, including for example, failure of riders to control their horses, the existence of tree branches and roots, animal burrows, erosion, slippery and uneven footing, rocks and other conditions. I agree that natural and man-made conditions are an inherent risk of horseback riding. I voluntarily assume the risks of encountering these conditions, including without limitation conditions caused in whole or in part by the negligence of the Releasees.
